FFO represents GPT's underlying and recurring earnings from its operations. This is determined by adjusting statutory net profit after tax under Australian Accounting Standards for certain items which are non-cash, unrealised or capital in nature. FFO has been determined in accordance with the guidelines established by the Property Council of Australia.

6.0 Details of any dividend or distribution reinvestment plans in operation

The distribution for the six months period ended 30 June 2015 was declared on 23 June 2015 and is expected to be paid on 11 September 2015. The Distribution Reinvestment Plan (DRP) was activated for this distribution, at a 1.0% discount to the volume weighted average GPT trading price for a period of 15 business days commencing from the business day following the record date of 30 June 2015. The last date for the receipt of an election notice for participation in the DRP was 1 July 2015.
