- Election of Mr Shane Gannon as a Director
- Adoption of the 2022 Remuneration Report
- Grant of performance rights to the Company's Chief Executive Officer and Managing Director, Mr Bob Johnston (long term incentive)
- · Increase in the Non-executive Director fee pool; and
- Amendments to the GPT Management Holdings Limited and General Property Trust constitutions

## Voting ahead of the AGM

You may appoint a proxy to vote on your behalf. Proxies must be received no later than 10:00am (Sydney time) on Monday 8 May 2023. Even if you plan to attend in-person, we encourage you to submit a proxy. This will ensure your vote will be counted if for any reason circumstances change and you cannot attend on the day.

To submit your proxy vote online go to <u>https://investorcentre.linkgroup.com</u> and login using the holding details as shown on this letter. Select 'Voting' and follow the prompts to lodge your vote. To use the online lodgement facility, securityholders will need their 'Holder Identifier' (Securityholder Reference Number (SRN) or Holder Identification Number (HIN)). You can also vote on your mobile device by scanning the QR code below.



Other methods for voting and proxy submission are outlined in the Notice of Meeting.
